During the Month of December the LCSD responded to 120 Incidents in the Town of Hyde Park, 149 Incidents in the Town of Johnson and 28 Incidents in the Town of Wolcott. There were 3 Agency Assists in the Town of Cambridge, along with 2 Special Overtime Shifts at the request and expense of Union Bank and 1 Lock Out at the request and expense of an attorney.

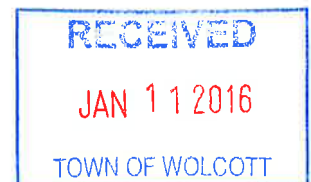
