During the Month of September the LCSD responded to 182 Incidents in the Town of Hyde Park, 243 Incidents in the Town of Johnson and 64 Incidents in the Town of Wolcott. There was 1 Agency Assists in the Town of Cambridge, along with 2 Special Overtime Shifts at the request and expense of Union Bank. We also had 1 Agency Assist in the Town of Eden and 1 Special Overtime Detail for Eden Days (at the expense of the Town of Eden).

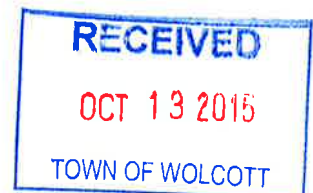
